She participated in numerous training seminars, conferences, as well as in innovative educational programs as an organizer and trainer. He is a successful organizer of school celebrations and theater performances. She was the initiator of social activities in the school where she works. He is an associate member of the Athletic Club ENOA.

Vaia Dimitrios Ntouska is a full-time doctoral student with studies in English in professional field 1.2. Pedagogy (Preschool pedagogy - Intercultural education) in the "Preschool and media pedagogy" department of the Faculty of Educational Sciences and Arts of Sofia University "St. Kliment Ohridski".

## 3. Actuality of the issues of the dissertation work

The modern social and educational situation in the Republic of Greece, as in Bulgaria and in all European countries, necessitated a rethinking and breaking of the pedagogical models in the educational system. Skillfully expanding the inclusive idea in the direction of attention to all children and finding an intersection with intercultural education is a bold, very significant step in terms of research and application. Contemporary theories on the development of intercultural education impose inclusive discourse as key to its effectiveness. In this sense, connecting inclusive education with inclusive intercultural education and highlighting the role of physical education as a connecting, accessible and effective part of the pedagogical toolkit for the social inclusion and integration of migrant children from an early age is significant and makes the topic of dissertation work undisputed.

#### 4. Structure and content of the dissertation work

The presented dissertation work is structured according to the scientific standards that are required for this type of development. Its contents include: introduction, five chapters, conclusion, conclusions, recommendations,

bibliography, appendices, author's contributions and publications of the doctoral student. The dissertation has a total volume of 235 pages, of which 39 pages are a bibliography and 10 pages for appendices. The text includes 91 tables and 11 figures. The bibliography includes 461 titles in English.

No plagiarism was found in the dissertation.
